On 02/24/2012, Sexual Assault Response Team (SART) advocate "Cindy" contacted the Sex Crimes Section relative to a victim of a sexual assault wishing to report an incident. Arraignments were made for the victim to respond Police Headquarters on 02/27/2012 at 10:00 AM with "Cindy" to report the incident.

On 02/27/2012 at approximately 9:45 AM, the victim arrived at Headquarters. She was met in the lobby by Sex Crimes Detective Keith Paulitsch, DSN 6275, who escorted her to the Bureau of Investigation and Support's fourth floor conference room. Detective Paulitsch obtained the victim's pedigree information and a description of the suspect. The victim described the suspect as a . He worked at

The victim disclosed that she is currently unemployed and recently divorced. She was looking for work when a friend suggested that she work at

The victim applied and was hired by the bar on approximately 02/07/2012. She completed the training process and was starting her regular shifts.

On 02/14/2012, the victim responded for work and met a subject who identified himself as ., who will herein be referred to as the suspect. The suspect stated that he was and that they will be working together in the future. The victim continued her shift without incident.

On 02/18/2012, the victim responded for work. It was a busy day due to the Mardi Gras celebration occurring in the city. The suspect was also working that evening.

Throughout the evening, the victim was offered several shots of alcohol by fellow employees at the bar, including the suspect. The victim initially refused because she rarely, if ever, drinks. She eventually succumbed to the pressure and began taking shots. She estimated she had 5 shots before she began pouring them out.

Once the bar closed at 3:00 AM on 02/19/2012, the victim went outside to smoke a cigarette. The suspect followed her outside and attempted to grab and kiss the victim. She resisted his advances and stated that she had a boyfriend and the suspect was married. The suspect ceased his advances and returned to the bar.

When the victim returned to the bar, two other employees, only identified as were walking out of the door. They stated they were going to get cigarettes at a nearby gas station. This left the victim and suspect alone in the bar.

Once alone, the suspect approached the victim and told her that since it was Mardi Gras, she had to show him her breasts. The victim refused. The suspect then pushed the victim against a wall, pulled her shirt up, and put his hand down her pants and underwear. The victim was telling the suspect to stop while he responded with phrases such as "Tell me you love me" and "Hush. No one needs to know." The victim is unsure if the suspect penetrated her vagina with his hand because she was struggling.

The victim was able to free herself and attempted to flee from the suspect. He was able to catch her as she continued to struggle and tell the suspect to stop. During the struggle, the suspect rubbed the victim's face with the hand he had down her pants and tried to put his fingers in her mouth. The suspect was able to eventually pin the victim against the bar with her front facing the bar and her back facing the suspect. She felt the suspect trying to pull down her pants and underwear as she continued to struggle. Before he was able to pull down her pants,

returned from the gas station. This caused the suspect to let go of the victim. She was able to run down to the end of the bar and straighten her disheveled pants. She looked back at the suspect and noticed his pants around his ankles. She did not see the suspect's penis due to the length of his t-shirt.

As the victim was composing herself, the suspect grabbed her by the arm and told her that she was going upstairs with him. She refused and was dragged to a stairwell landing by the suspect. Once at the landing, the suspect tossed her over his shoulder and carried her up the stairs. At the top of the stairs, the suspect put the victim on a table top. While on the table, appeared in the room and inquired what the commotion was about. The suspect replied nothing was wrong and allowed the victim to flee back downstairs to the bar. The suspect remained upstairs.

Once downstairs, told the victim that it looked like she needed help. The victim replied that the suspect was getting "handsy". The victim remained at the bar since she felt she was unable to drive due to her alcohol consumption. She eventually thought she heard the suspect coming down the stairs and became afraid. She grabbed her keys, fled the bar, and went back to her residence.

The victim did not report the incident until her sister observed bruises on her arms where the suspect grabbed her. The victim was convinced to contact SART,

who in turn contacted this Department at the victim's request. The victim took pictures of the bruises however these were unavailable at the time of this report. The bruises had faded prior to the victim responding to Headquarters. Later attempts will be made to retrieve these pictures from the victim.

After the completion of the interview, Detective Paulitsch informed the victim that a possible suspect had been discovered and inquired if she would view the photo lineup that had been prepared by Detective Noble. The victim agreed. Prior to viewing the lineup, Detective Paulitsch advised the victim that the suspect may or may not be pictured and that she was under no obligation to choose a photograph. The victim stated she understood. The lineup was presented in the well lit conference room.

er looking at each photograph, the victim pointed to photograph and stated "That's him. That's The victim initialed and dated the photograph of indicating she made a positive identification. The lineup was seized as evidence and later conveyed to Property Custody for storage. The victim also signed a Photographic Lineup Acknowledgement Form indicating she made a positive ID. The form was scanned into this report as an attachment.

residence by Detective On 03/04/2012, an arrest attempt was made at Paulitsch and Sex Crimes Detective Dana Pickett, DSN 4170. This attempt was to no avail however the detectives located a subject who identified herself a Detective Paulitsch gave his contact information to requested that she pass it along to agreed.

Detective Paulitsch informed her of the investigation and requested an interview. stated she was very busy however agreed to be interview over the phone. The following is a summary of that interview.

, whose correct first name is stated she was working on 02/18/2012 at the and recalled the victim working as well. She knew the victim as for , which is a moniker the victim uses. Throughout the consumed a large night, the victim consumed several shots of alcohol. amount of alcohol and became highly intoxicated.

When the bar closed, the only people remaining were and the victim. was extremely intoxicated and asked victim to show their breasts to each other. They both agreed and exposed the breasts. This was the only sexual activity observed.

At one point after the bar closed, observed . holding the victim as if he was trying to stay upright. He appeared to be getting sick so the victim helped him upstairs. and went outside and unintentionally locked the door behind them. After several minutes, the victim vomited. The victim then came outside and told

NARRATIVE

Relative to the victim disclosing she was sexually assaulted by on 02/19/2012, Sex Crimes Detective Keith Paulitsch, DSN 6275, wishes to state the following.

On 03/07/2012 at approximately 9:00 am, . responded to Police Headquarters and was met in the lobby by Detective Paulitsch. He was escorted to the Bureau of Investigation Support's fourth floor interview room #1. Detective Paulitsch informed that he was under arrest for the listed charges and secured him in the room. Detective Paulitsch exited the room and began the digital recording (audio and visual).

Detective Paulitsch reentered the room and again advised of the charges against him and of his Miranda Rights. He stated he understood and wished to make a statement. The following is a non-verbatim summary of that interview. Refer to the DVD recording for complete details.

. stated he owns the with his brother, . They recently hired a new bartender named () Note that is a moniker the victim uses. He was working with the victim on 02/18/2012.

When the bar closed in the early morning of 02/19/2012, the only employees left were the victim, and himself. They all consumed a large amount of alcohol throughout the evening and became extremely intoxicated.

— remembered asking the victim and to show their breasts, to which they complied. He then began to feel sick so the victim helped him upstairs. Once upstairs, he vomited in the restroom and passed out. The victim left and he has not seen her since. He claimed the only sexual contact between him and the victim was when she showed him her breasts.

When confronted with the victim's allegations, adamantly denied any sexual contact with the victim. He also agreed to take a polygraph examination to prove his innocence.

Detective Paulitsch exited the room and contacted ATF Special Agent Michael Johnson and requested that he respond to Headquarters to administer the polygraph. Agent Johnson agreed and responded to Headquarters within an hour. Detective Paulitsch then ceased his interview with and stopped the recording.

Once Agent Johnson arrived at Headquarters, he was briefed on the details surrounding the incident.

. was led to the polygraph examination office where he made contact with Agent Johnson, who then began the polygraph examination.

Upon the completion of the polygraph examination, Agent Johnson informed Detective Paulitsch that failed the examination and now wished to make a truthful statement to the detective. Detective Paulitsch escorted back to interview room #1 and began a second recording (audio and visual). The

following is a non-verbatim summary of the second interview. Refer to the DVD recording for complete and accurate details.

stated that he requested that the victim show him her breast to which she complied. He then proceeded to rub her bare breasts with his hands. They then went outside where they kissed. This was a consensual act.

Since was feeling sick, he decided to go upstairs. The victim came along but since she was also intoxicated, had to pull her up the stairs by her arm. Once upstairs, the victim left first floor. A short time later, called for the victim who returned upstairs.

Once the victim returned, they began to kiss. This led to . placing in hand down the front of the victim's pants and underwear and feeling the outside of her vagina. The victim was also feeling on the outside of scrotch over his clothing.

This sexual activity was interrupted by entering the room. Once the activity stopped the victim went downstairs and left the bar. communicated with the victim the next day via text messages about bar receipts and her next available day to work. The victim replied that it was not worth her time working there.

stated the sex acts were completely consensual and that he was initially untruthful because he did not want his wife to find out. He denied any sexual activity down stairs on the bar. He also denied that left the bar and later returned.

Detective Paulitsch ended the interview with and booked him on the listed charges. He was later released Pending Application of Warrant.
